2. COMPOSITION/ INFORMATION ON INGREDIENTS.

The product does not contain any substance presenting a health hazard within the meaning of the CHIP Regulations.

3. HAZARDS IDENTIFICATION

The product is not classified as dangerous according to the CHIP Regulations (refer also to Section 11)

4. FIRST AID MEASURES.

General

In all cases of doubt, or when symptoms persist, seek medical attention.

Never give anything by mouth to an unconscious person.

Inhalation

RECOMMENDATIONS
